# LEGISLATIVE COORDINATING COMMISSION

## LEGISLATIVE INDEX DEFINITIONS/GLOSSARY OF TERMS

### 1. PROCESS TYPE:

Identifies what category/process type each piece of legislation falls under. Choices are as follows:

- **Type 1:** Empowerment:  
Laws of General Application, Laws of General Application or that affect the entire community.
- **Type 2:** Regulatory:  
Laws that affect only a portion of the populations (or specific interest group). These laws are usually regulatory, financial and/or administrative in nature.

### 2. ORIGIN:

Identifies under what system each piece of legislation was enacted. Choices are as follows:

- **Federal:** Registered By-law; (sometimes referred to as a Communal Law)
- **Kahnawá:ke:** Mohawk Law; (sometimes referred to as a Mohawk Law)

### 3. STATUS:

Identifies the status of each piece of legislation. Choices are as follows:

- **Inactive:** Draft and/or Incomplete legislation (either in content or process).
- **Active:** In force and/or successfully enacted legislation  
(Include MCR/MCED numbers and dates)

**4. REQUESTS FOR LEGISLATION FOR COMMUNITY DECISION MAKING PROCESS (RFL/CDMP):**

Identifies whether an official request for submission into the CDMP has been submitted/received. Choices are:

- **No:** No further information required
- **Yes:** If yes, the following information must be provided:
  - a) For what purpose (Enactment or Amendment);
  - b) On what date (date of official Request for Legislation).

**5. MCK LEGAL SERVICES REPRESENTATIVE:**

Identifies the MCK Legal Services Representative assigned to work on the piece of legislation. This individual will become a part of the LCC Technical Team for the duration of the Community Decision-Making Process for the piece of legislation.

**6. MCK / 3<sup>RD</sup> PARTY TECHNICIAN:**

Identifies the MCK and/or Third Party Technician responsible for the management of the content for the piece of legislation in question. This individual will become a part of the LCC Technical Team for the duration of the Community Decision-Making Process specific to this piece of legislation.

**7. MCK PORTFOLIO TITLE:**

Identifies the MCK Portfolio in which the legislation currently falls, as follows:

- Commissions & Boards (Justice, Gaming Commission, Peacekeeper Services Board & Alcohol Beverages Control Board)
- Community Decision Making Process
- Community Protection
- Economic Development
- Education
- Finance, Administration and Operations
- Health
- Intergovernmental Relations
- Labour

- Seigneurie of Sault St. Louis
- Social Development
- Specific Claims
