

Summary Report of Survey Results

This report concerns the survey initiated by the Kahnawà:ke Legislative Coordinating Commission (KLCC), which ran from January through August 2013. The intent of the survey was to find out what perceptions the community had already about Community Decision Making Process (CDMP), why there was such a low turn-out at community hearings, and to educate community members about the existing process. Overall the survey was successful, in that community members were willing to participate in the survey.

This campaign attempted to survey respondents from Kahnawà:ke, QC. The respondents were contacted using the 2010 Kahnawà:ke phone directory, which was unfortunately not up to date. Every household was contacted, with a total of 390 respondents who were willing to participate in the survey to a varying degree.
