**1. Previous Record of Conclusion (ROC) January 12, 2012**

**2. KLCC Community Representative****Discussion:**

Roles and responsibilities

**Decision:**

KLCC members can give their personal views at a Hearing of a Type I law. Once the mandate has been given, they are there as a KLCC member. After the mandate has been determined by the community, their participation is as KLCC member, whereby they cannot give their personal opinion but act in the capacity as a KLCC member supporting the process, not getting involved in the content of the amendment to the law.

- B) Redefine KLCC quorum

**3. Presentation to Conference****Discussion:**

Kahente requested approval to submit a Proposal to the Indigenous Peoples and Governance Call for Papers on “How to Break out of Colonialism” April 17 – 20, 2012 in Montreal.

**Decision:**

Request approved. Kahente will submit her draft to KLCC before sending it to the Indigenous Peoples and Governance International Conference and will only attend other sessions as relevant to the CDMP.

**4. File Updates**

**Sanitary Conditions**

**Discussion:**

Only require an amended Certification of the Process form. The Confirmation of the Will of the People form is not necessary for Type II Laws and was designed for Type I Laws. The MCED replaces the need for The Will of The People form.

**Decision:**

**Next Steps:** Before KLCC goes to Council Legislative Session for an MCR to pass the Sanitary Conditions Law, we need the Budgetary Implementation Plans.

**Anti-Tobacco Law**

**Discussion/Decision:**

It needs to move along to the next step, but before it does, the Technician needs to submit a work plan and minimum communication standards, then the community consultation/Stakeholder Consultation (Community Hearing) could be organized.

***ACTION:***

***Kahente request Jeffrey Diabo (Technician) to send his Anti-Tobacco work plan and minimum communication standards to KLCC by email. He then needs to start organizing consultation with the community stakeholders.***

**Justice Act**

**Discussion:**

The draft Justice Act is currently being reviewed by MCK Legal Services. Once approved, it would be coming back to KLCC, and then would go to the First Hearing of Phase II.

**Election Law**

**Discussion:**

Trina C. Diabo, Technician for the Election Law, completed and submitted a report on Phase 2 - Dissemination of Information for Amendments to the Election Law.

**Decision:**

**Next Steps:**

1) Submit updated minimum communications and work plan and prepare to answer questions at the First Hearing.

- 2) Organize the First Community Hearing to get the mandate from the community to amend the Election Law.
