2. MCK Legislative Session – September 6, 2011

Sanitary Conditions Law (SCL):

Discussion: The format of the SCL Final Draft #12.

Decision: The changes should be in grey, deletions in separate document and the original law attached. There will be three documents: Introduction, Original Law and Deletions showing the changes to-date. Once changes are completed, Draft #12 will be posted on kahnawakemakingdecision.com website for the 30-Day Review, and then the Second Reading will be scheduled.

KLCC Mandate:

Election Law:

Discussion: The categorization of the Kahnawake Election Law has now been qualified as a Type I piece of legislation.

ACTION:

Inform Council (through memorandum) that the categorization of the Kahnawake Election Law has been confirmed by the LCC as a Type I piece of legislation.

4. <u>Social Development Unit Committee - Terms of Reference Amendment:</u>

For information purposes, Jean informed that the SDU Terms of Reference (TOR) was brought in through an MCR however, now TOR is brought in using an MCED. Legal cannot change an MCR with an MCED; however an exception will be made for this time only.

KLCC will advise Council (through memorandum) that the Social Development Unit's TOR should be changed with an MCR. That MCR will indicate that from this day forward the TOR would be changed with an MCED.
