2. FILE UPDATE REVIEW/DECISION	<ul style="list-style-type: none"> • Rescinding Laws and KLCC's role –Kevin Discussion concerning the process, if any, for rescinding or repealing laws. There is the possibility that a request will be made to repeal a law and it is unclear what role, if any, the KLCC would have in such a matter. The KLCC Mandate and Manual do not include such actions. <p>It was discussed whether the KLCC should have a process to handle all aspects of rescindments, repeals, replacement. Currently no process exists. Suggestion: Schedule KLCC meeting to develop criteria for rescinding/repealing laws then bring to Council Strategic Discussion to determine KLCCs role.</p> <ul style="list-style-type: none"> • Status of CDMP Procedural Manual – Kevin/Leslie/Kahsennenhawe <ul style="list-style-type: none"> ○ Updated process flow charts – approval Perhaps the CDMP Procedural Manual should be completed with all of the details before flow charts are decided upon. The charts are intended to be a snapshot. There should be deliverables or bench marks to indicate the end of the First Hearing and what starts the Second Hearing. <p>Type I Flow chart: First Hearing: The draft law is reviewed. The community debates and discusses the law presented within the purpose, scope and mandate established in Phase I. A Declaration of Conclusion of the First Hearing is made (by the head of the KLCC). Second Hearing: A 30 day review period to determine: "did we get it right?" Phase III is good.</p> <p>Type II Flow chart: Phase I and II: Replace 15 days with 30 days to prevent confusion and to provide enough time for review Council ratifies law is removed from Phase II. The definition of a Kanien'kehá:ka Great-grandparent was not concluded. There was a lot of discussion surrounding blood quantum in light of Kanien'kehá:ka lineage. A chart is to be prepared by Membership to show the impacts of using 25%, 30% and 50% blood quantum to determine who is a Kanien'kehá:ka Great-grandparent. There was a reported outcry concerning a decision that had been made at the meeting held on March 8th. KLCC unanimously decided that the decision stands. • Tobacco Law – Kahsennenhawe/Joe/Dale A brief update of Tuesday's Tobacco CDMP was presented. There was a proposal to hold KML/Tobacco CDMP hearings 2 weeks on and 1 week off. So the next Tobacco hearing would be the week of the 25th. There was a question about this law going through the urgent process; therefore there is only one hearing. • Election Law – Kevin Deferred
