• Proposed Amendments to MCK Election Law-Leslie Skye

The dissemination of information for the Cannabis Law has been divided into two parts; from an economic and health perspective. The Portfolio Chiefs are Gina Deer (Economic with assistant from Paul Rice) and Rhonda Kirby (Health). Dennis Diabo (Technician) has completed the Political Assessment.

• Kahnawà:ke Family Homes Law – Leslie Skye

KLCC is scheduled for Council Strategic Discussion on Wednesday, December 13, 2017 to inform Council that the law is 'INACTIVE' and will be taken off of the Legislative Agenda/Calendar. Resubmission of a new version of the Law in the New Year is recommended.
