WHEREAS the Mohawk people of Kahnawake (Kanien'keha:ka Kahnawakehró:non) as part of the Mohawk Nation (Kanien'keha:ka) and the Iroquois Confederacy (Haudenosaunee) are and always have been a sovereign people, and

WHEREAS the Kanien'keha:ka Kahnawakehró:non have consistently and historically declared their ultimate and exclusive jurisdiction over the Territory of Kahnawake, and

WHEREAS the Kanien'keha:ka Kahnawakehró:non have consistently and historically declared their right and responsibility to govern their own affairs, and

WHEREAS the Kanien'keha:ka Kahnawakehró:non have stated their intention to reinstate the structures, philosophies, concepts and principles of Mohawk Traditional Government as embodied by the Great Law of Peace (Kaianereko:wa), and

WHEREAS Kanien'keha:ka Kahnawakehró:non abide by the principles of Power, Peace and Righteousness prescribed in and in accordance with the Kaianereko:wa, and

WHEREAS these principles have governed, and continue to govern, the direction of the Mohawk Nation since time immemorial, and

WHEREAS the Mohawk Council of Kahnawake has previously enacted or amended Election Regulations in 1988, 1990 and 1996, and

1. All previous Election Regulations enacted or amended by the Mohawk Council of Kahnawake are hereby repealed and replaced by the "Regulations Governing the Mohawk Council of Kahnawake Elections, 03, Onerahtókha/April 2000", a copy of which is attached hereto as Schedule "A" (the "Election Regulations, 2000");
2. The Election Regulations are hereby enacted, effective 03, Onerahtókha/April 2000.
